#### STAGE 3 PERFORMANCE TEST NOTES

This stallion has developed moderately since his Stage 1 Inspection seven months ago, and he needs more time and training to mature physically and to strengthen his back, loins, and hindquarters. His jumping technique with his front legs has improved, while his hind leg technique has remained good. His canter has a good length of stride, but should become more balanced. He jumps enthusiastically and carefully with good technique, and works with and for the rider. He has good ability now, and should develop more in time. He is suitable for both showjumping and eventing breeding. He should bring a good canter and jumping technique to his progeny, along with a willingness to work and be trained. The mare should bring a well-developed top-line, and good forelegs, feet, and rideability. For eventing breeders, the mare also should have a good walk. He should suit both heavier and modern mares.

Stable Behavior: Good stable behavior. No stable vices observed.

Behavior with Humans: Good behavior toward humans.
